Sub: Petition to surrendering my personal security staff which is allotted by Government of Telangana, for irrespective and irresponsible acts and deeds of the Commissioner of Police, Karimnagar, who is violating the privileges and precaution of security and in press note false statement was issued about the incident occurred on 18-01-2020 against me – Kindly take immediate necessary action on Commissioner of Police Karimnagar - reg.

It is kind attention to brought notice to your authority that, yesterday the Commissioner of Police, Karimnagar irresponsibly issued a public press note with false contents that, during the campaigning in Municipal Elections, on 18/01/2020 at Sharma Nagar, near Pochamma Temple some MIM political party activists, preplanned, knowing my canvassing area in order to disturb the peace and harmony, they are gathered and thrown the stones towards the procession of canvas at Sharma Nagar, in that incident one Constable who named by Gnaneshwar belongs to II Town Police Station, Karimnagar sustained injuries and some of the party voluntaries also sustained injuries, to restore peace during the period of elections, the said incident was not reported to Police and not published in Print and Electronic media, but the Special Branch Police and Intelligence immediately received the information through their enquiry for protection additional security was tentatively arranged on the next day. The Commissioner of Police, Karimnagar is not discharging his official duties

perfectly, the vague statements are published in the Print, Electronic and Social Media without investigate and enquiry with regard to the above matter and also not confirmation about the incident from me also false statement is published during the period of this election by wrong message to the Public in order to damage the respect as a Member of Parliament. This incident is very seriously received our Party voluntaries who are present at that time and brought notice to me the Commissioner of Police exceeded his powers, irresponsible and irregular false statements are delivered to media, this is not only first time in the year of 2018 and onwards twice incidents are occurred by targeting me. In one occasion, the MIM Party activists are thrown stones on my house and our party voluntaries, at that time also Commissioner of Police, Karimnagar not registered any case against MIM Party activists, who thrown the stones.

It is submit that, on 18-01-2020 incident took place not at all enquired either by Commissioner of Police or by any officials of Police and not reported the same, but the higher officials immediately taken fast steps and provided additional security for prevention, without knowing this fundamentals and without consulting me about the incident, how the Commissioner of Police imagine as a false incident and the post of social media is also treated as a false. After seeing such statement of Commissioner of Police, the duties and responsibilities of the Police Department much know to provide security and additional security for prevention of the above incidents if any re-occurs, but here the Commissioner of Police stated that "no incident was occurred" and he committed for peaceful atmosphere. As per the Commissioner Statement, I was surrendering my personal security with additional security which is provided by the Government.
